## Chairman's Report – Rod Kimmitt

It is with great honour that I table this first annual Cricket Southern Bayside Chairman's Report and what an amazing 12 months it has been. It seems incredible that as late as March 2016 Cricket Southern Bayside was no more than an idea, yet here we are a little more than 12 months later part of an organisation that is held up as a template for the future.

Clubs expressed a desire to challenge the status quo. They wanted to be part of something fresh and innovative. They were no longer happy with mere existence, they wanted to thrive. They wanted to be engaged. Most importantly they wanted the best possible cricket experience for their members. They told us they wanted:

- More streamlined and two-way communication
- A stronger and more agile governance structure

This new structure of a Board of Governance, supported by Advisory Groups, was formally endorsed by the foundation clubs at the Extraordinary General Meeting on July 27<sup>th</sup>, 2016. Cricket Southern Bayside was officially born with the working party appointed as the inaugural board. In addition to myself those inaugural directors were Andrew Lasky, Andrew Kahofer, Paul Glew, Graeme Cunnington, Sven Samild, Satbir Singh, Campbell McLeod and Chris Hall. Since that day, and in fact before, this group have worked tirelessly to deliver on our promise to provide a participant focussed experience with a new level of transparent communication and engagement. I am extremely proud of this group and firmly believe we have delivered on our promise.

One of the first tasks of the new board was to appoint the first Cricket Southern Bayside Head of Cricket. After an extensive and thorough search, we took great delight in appointing Warren Griffin to the position. Since his appointment Warren has stepped up to every challenge thrown at him and shown great leadership in driving the Cricket Southern Bayside vision forward. We are fortunate to have found such a dedicated and skilled person to take on this role.

Cricket Southern Bayside has led the way as the new face of community cricket. From pink balls to T20 double headers, white ball ladders to promotion/relegation. We have not been scared to innovate to find the best experience for our members and we will continue to do so. Importantly we have shown that you can move forward whilst respecting the past traditions of our great game.

- To our sponsors and supporters, PPG Taubmans, Cricketers Arms, Kookaburra and Bentleigh RSL – your contributions to our sport are invaluable and we look forward to growing our partnerships over the coming years
- To our Local Government partners – Local governments are without doubt the biggest sponsors of community sport and we acknowledge your support on behalf of all clubs
- To Cricket Victoria – we thank you for both your financial and secretarial support. You have provided us with the resources to build an organisation for the future

## Report from Head of Cricket Southern Bayside – Warren Griffin

As we look forward to next season it is hard to believe that we have completed the first year of a competition that did not exist barely 12 months ago.

Starting afresh gave opportunity to challenge what had gone before and to look for new ways to reinvigorate competition amongst the turf clubs in the southern bayside region. It also provides an opportunity to establish a base from which we can create a unique and innovative cricket region for Australian cricket.

In the creation of CSB, working parties moved quickly to establish branding, structure, a fresh governance model and of course playing conditions.

In the early stages of the development of the competition, clubs were given the opportunity at forums to identify what they would like to see in governance and operational management of the competition. Several items were identified and prioritised and I am pleased to report that following the end of season player and club survey that the top 6 issues from those forums have all shown significant improvement in their ratings.

Those issues and the results from the pre-and post-season surveys can be seen in Table 1.

From the player surveys, a total of 81.5% of the responses rated their season as satisfied or better (22% rating it as extremely satisfying).

On the pitch, CSB delivered coloured clothes across all grades with white balls in one day and T20 matches, the well-received double header T20 games, a pink ball round and our 8 team grades, all providing plenty of competitive cricket and reigniting old local rivalries in new conditions.

Earlier finishing times were popular as was the separate White Ball Final but unfortunately weather intervened on the day and so did the rule book. The deciding scoresheet whilst in use all season (used in several other competitions not just CSB) threw up some interesting and unpopular results in games. Whilst those results were not the ideal way to promote that initiative, the event, like the double header T20 games provides opportunities for clubs to promote themselves, run social events and provides exposure for sponsors and the ability to generate much welcome income.

One area that did not immediately improve was the workload required by administrators, but with the new competition, implementation of new rules, processes and procedures this should also improve as the competition matures.

We will also continue to work with the umpire department at Cricket Victoria to recruit and train umpires, who we all know are a key component to running a successful competition. We have taken several steps including the appointment of an umpiring manager, launched a recruiting drive for next season with information being sent to umpires living in the Bayside area, promoted via Cricket Victoria's website and our bulletin and its pleasing that we have already picked up a few new umpires. We look forward to this and other steps we have identified bearing further fruit before the start of next season. I'm grateful for the relationships that we could build with our umpiring fraternity last summer, and the decision they took in coming on board with new rules and processes. And I look forward to strengthening those relationships into the future as we work to develop further training and social opportunities for our umpires.

We also took steps off the ground by hosting our first Chairman's lunch with Rodney Hogg, Tim Lane and Tony Dodemaide as our guests. This is an event we would like to build upon this coming summer and look forward to it becoming a key event on the Cricket Southern Bayside calendar.

I would also like to thank Cricketers Arms for coming on board to support our finals series, their support has been gratefully received and we look forward to working with the team at Cricketers Arms into the future. Also, a thanks

to the Bentleigh RSL for the use of the function room and boardroom regularly throughout the season, that support is much appreciated as is the support of Kookaburra, who have been terrific to deal with.

I'm excited to have PPG Taubmans come on board for the start of the 2017/18 season and look forward a long future together.

Thanks to Gary Murray as Ground Manager and his regular calls to discuss the weather, pitch maintenance and processes for each upcoming weekend.

Thanks also to Luke Shelley our roving photographer who has captured some terrific images enabling an image library to be created which we encourage clubs to utilize.

Mick Hogan deserves much thanks for organizing the five VMCU under 21 games, whilst we didn't get the results we desired it was a great way to get the CSB brand out into the cricket community.

Cricket Victoria is to also to be acknowledged for its support in assisting the competition to become established. A few resources at CV were tapped it into and support provided freely and without encumbrance, allowing CSB to make its own decisions and chart its own course.

Cricket Southern Bayside is a work-in-progress and we won't be resting on the achievements of one season. Rules and fixturing are being reviewed, with club and player survey results considered as we look to adjust for season 2017/18.

We will look for opportunities to expand the competition through not only new clubs whom are attracted to formats, proximity and enjoyment CSB is delivering, but will also look to identify other cricket opportunities that can increase participation and grow our clubs and cricket in general.

With the season completed we all deserve to take a few moments to look back and review the change that has been made to the local cricket landscape and the positive impact that the foundation clubs have now made to cricket in the region.

Finally, I would like to thank the members of the CSB Board and the Clubs for their support throughout the season and I look forward to growing cricket across Southern Bayside.

### Cricket Southern Bayside Inc.

#### Notes to the financial statements for the year ended 30 June 2017

##### 1. Statement of significant accounting policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

##### a) Statement of compliance

The committee has determined that the incorporated association is not a reporting entity because there are no users dependent on general purpose financial statements. The financial report is a special purpose financial report which has been prepared in order to satisfy the financial reporting requirements of the *Associations Incorporation Reform Act 2012*.

These financial statements have been prepared in accordance with following Australian Accounting Standards:

AASB 101	Presentation of Financial Statements
AASB 108	Accounting Policies, Changes in Accounting Estimates and Errors
AASB 1031	Materiality
AASB 1048	Interpretation of Standards
AASB 1054	Australian Additional Disclosures

##### b) Basis of measurement

The financial statements have been prepared on an accrual basis and are based on historical cost and do not take into account changing money values except where specifically stated.

##### c) Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

##### Plant and equipment

Although there are no reported values associated with Plant and equipment, it follows that any Plant & equipment will be measured on the cost basis less depreciation and impairments losses.

The carrying amount of plant and equipment is reviewed annually by the committee members to ensure that it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

##### Depreciation

Although there are no reported values associated with Plant and equipment at cost, it follows that the depreciable amount of all fixed assets, excluding freehold land will be depreciated on a straight-line basis over the asset's useful life to the association commencing from the time the asset is held ready to use.

The depreciation rates that will be used for each class of depreciable asset are:

Plant and equipment 20%

Motor vehicles 25%

The assets' residual values and useful lives will be reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount will be written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals will be determined by comparing proceeds with the carrying amount. These gains and losses will be recognised immediately in profit and loss.

When revalued assets are sold, amounts included in the revaluation surplus relating to that asset are transferred to retained earnings.

#### **d) Impairment**

At each reporting date the committee assesses whether there is objective evidence that a financial instrument has been impaired. If any such indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

#### **e) Income tax**

The association is a not-for-profit organisation and is exempt from income tax under section 50-45 of the *Income Tax Assessment Act 1997*.

#### **f) Cash and cash equivalents**

Cash and cash equivalents includes cash on hand, deposits, held at call with banks, other short-term highly liquid investments with original maturities cash within three months.

#### **g) Revenue**

Revenue is measured at the fair value of the consideration received or receivable. Donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

#### **h) Inventory**

Inventory held for sale are measured at the lower of cost and net realisable value.

#### **i) Goods and services tax (GST)**

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisition of an asset or as part of an item of expense. Receivables and payables are stated inclusive of GST.

#### **j) Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of assets that necessarily take a substantial period of time to prepare for their intended use or sale are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in income in the period in which they are incurred.

#### **k) Trade creditors and other payables**

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the company during the reporting period, which remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days on recognition of the liability.

## **Review report – CRICKET SOUTHERN BAYSIDE INC.**

To the members of Cricket Southern Bayside Inc.

### **Report on the financial report**

We have reviewed the accompanying financial report of Cricket Southern Bayside Inc. which comprises of the balance sheet as at 30 June 2017 and the income statement for the year then ended, notes comprising a summary of significant accounting policies and other explanatory information.

### **Committee’s responsibility for the financial report**

The committee of the association is responsible for the preparation of the financial report that gives a true and fair view in accordance with the *Associations Incorporation Reform Act 2012*. The committee determines that the internal control is necessary to enable the preparation of the financial report that gives a true and fair view and is free from material misstatement, whether due to fraud or error.

### **Auditor’s responsibility**

Our responsibility is to express a conclusion on the financial report based on our review. We have conducted our review in accordance with auditing standard on review engagements ASRE 2410/ASRE2415 in order to state whether, on the basis of the procedures described, anything has come to our attention that causes us to believe that the financial report is not presented fairly, in all material respects, in accordance with the *Associations Incorporation Reform Act 2012*. As the auditor of the association, ASRE2410/ASRE2415 requires that we comply with the ethical requirements relevant to the audit of the annual financial report.

A review of a financial report consists of making enquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Australian Auditing Standards and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

### **Independence**

In conducting our review, we have complied with the independence requirements of the Australian professional ethical pronouncements.

## Conclusion

Based on our review, which is not an audit, I have not become aware of any matter that makes me believe that the financial report of the association is not in accordance with the *Associations Incorporation Reform Act 2012* including:

- a) giving a true and fair view of the entity's financial position as at 30 June 2017 and of its performance for the year ended on that date; and
- b) complying with Australian Accounting Standards as referred to in Note 1 to the financial statements.

## Basis of accounting and restriction on distribution

Without modifying our opinion, we draw attention to Note 1 to the financial report, which describes the basis of accounting.
